#### **Old Business**

**Department of Ag Update:** Motion made by Terry Greenwaldt, seconded by Marion Gill to give Darren the authority to sign the Amendment to release \$31,000. Opposed, none; motion carried. Darren and Luke are working on a work plan that will hopefully result in more money set aside for us.

**TSA Update:** Meeting was in Mahnomen. This committee is made up of Supervisor, however, due to lack of attendance, they have a hard time meeting a quorum. Everyone in attendance was bringing this back to their Board members for discussion. Two options were discussed: 1. Divide into two TSA's. and 2. Restructure delegations to allow either a supervisor or staff to represent the SWCD at these meetings. The By-Laws would need to be amended to allow staff to vote. After lengthy discussion motion made by Steve Inwards, seconded by Dennis Reynolds to submit that EOT SWCD votes to give voting rights to staff with the intention of working toward dividing into two TSA's. Opposed, none; motion carried.
